Preparing to meet with lawmakers



NAHN's Health Policy Summit is the biggest advocacy event of the year. Members from across the nation convene in Washington, DC to hear from NAHN Staff, leaders, and other experts on the most pressing health policy issues. On the final day of the conference, attendees join pre-scheduled meetings with members of Congress to share personal stories related to NAHN's Health Policy Summit talking points to help policy leaders understand the impact their legislative decisions have on Nursing, patient outcomes, and Latino communities. The Health Policy Committee plays a significant role in developing talking points (formal requests to Congress on behalf of NAHN) that are featured in NAHN's annual Health Policy Summit. When identifying talking points, they take into consideration legislation that NAHN has supported throughout the year and imminent issues that Congress is expected to address. They work to ensure that the talking points are focused on addressing issues specifically related to Latino Communities and nursing but also represents a wide range of NAHN's membership, touching on issues that resonate with everyone across all membership categories.

It is imperative that NAHN members continue conversations started on the national level in their home states. It is equally important that NAHN Chapter leaders take an active role in state policy & advocacy issues to advance the initiatives of NAHN, Nursing, and the Latino communities.
